RULES AND REGULATIONS

1. Name of the Society : D.S.GOVERNMENT DEGREE COLLEGE FOR WOMEN ALUMNI

ASSOCIATION

ONGOLE, PRAKASAM DISTRICT, ANDHRA PRADESH-523001.

3. Membership

All the members (old students, Teaching staff, Administrative staff) who have completed 21 years of age can join as members of the Society irrespective of caste. For that admission of Rs.200/- shall be paid. Every members shall pay Rs.100/- towards annual subscription. Any member who fails to pay the subscription for 3 times shall loose the membership or who fails to attend the general body or executive body meetings for 3 times shall loose the membership. The Executive Body has got right to remove if the Rules and Regulations of the Society are not followed.

4. General Body Meeting

All the Members who have joined as per Rule 3 shall be the members of the General Body Meeting. This shall meet in the month of September every year and conduct the following activities.

- To elect the Executive Committee once in every five years.
- To prepare the budget for ensuring year.
- To approve the receipts and expenditure statements of the previous year.

The Committee shall be managed by a Managing Committee consisting of the Teaching Staff, Administrative Staff and old students of the College initially constituted by the Head of the Institution, as:

Treasurer - 1
E.C Members - 4

Total - 9

6. Functions of the Executive Body:

- a. To disseminate information gained through several service organizations and to incorporate them in the proceedings of the Association.
- b. To organize and programmes inculcating the spirit of sacrifice and generosity from the gross route level of the hearts of the student community.
- c. To encourage the spirit of oneness in helping the poor and needy students.
- d. The members of Alumni Association shall meet at least once in a Year or in a specified time and discuss about the development activities of the College and to organize welfare programmes in the College.
- e. If vacancy arises in the middle, they shall be elected from the General Body Members through co-option and shall remain in the vacancy till the elections are conducted.

DUTIES OF THE EXECUTIVE BODY:

President: (Principal of the College is Ex-office Chairman of the Association).
 He/ She preside over all the Executive Body and General Body meetings.
 He/ She shall have power to inform the Secretary for organizing the special
